

Reporting Sexual Misconduct: A Guide for University of Louisiana at Lafayette Employees

If you receive a report of a Title IX matter (sex discrimination, including sexual harassment, sexual assault, and other sexual misconduct):

□ Employee must notify the Title IX Coordinator within 24 hours and refer Complainant to the Title IX Coordinator. The Title IX Coordinator will discuss options, interim measures, and the complaint process with Complainant (counseling, housing adjustments, class/work schedule adjustments, etc.).
